Transparency tool for risk assessment in the apparel and textile chain

The Challenge

The fashion and textile industry exists of complex supply chains. Many tiers, production often thousands of kilometers away and garments existing of multiple materials and treatments, make the garment industry very complex. Risk assessment to prevent and mitigate CR issues is very difficult and time consuming. Human rights, worker health and safety, animal welfare and environmental protection may be at stake with adequate monitoring.

There are more and more international and national initiatives that call for (Dutch) companies to not only know the risks in their supply chain, but mitigate them and create positive impact instead. The international agreements such as United Nations' Guiding Principles and Human Rights, the OECD's Guidelines for Multinational Enterprises, and the ILO's fundamental labour standards are good examples.

The focus in the fashion industry has mainly been on tier 1, the cut-make-trim of ready-to-wear garments and especially on working conditions. The challenge lies in facilities, suppliers and processes further upstream. Which suppliers, deeper in the chain, carry the risks when it comes to water use and pollution, energy use and hazardous chemicals? Are the employees in the factory well protected? There is a need for a simple and scalable way to make the supply chain more transparent and to assess risks.
