The plastic material of the product contains an excessive amount of bis(2-ethylhexyl) phthalate (DEHP), dibutyl phthalate (DBP) and diisobutyl phthalate (DIBP) and short chain chlorinated paraffins (SCCPs)(measured values up to 17%, 14% and 2.7%, 0.8% by weight, respectively). These phthalates may harm the health of children, causing possible damage to their reproductive system. SCCPs persist in the environment, are toxic to aquatic organisms at low concentrations and bioaccumulate in wildlife and humans, posing a risk to human health and the environment.

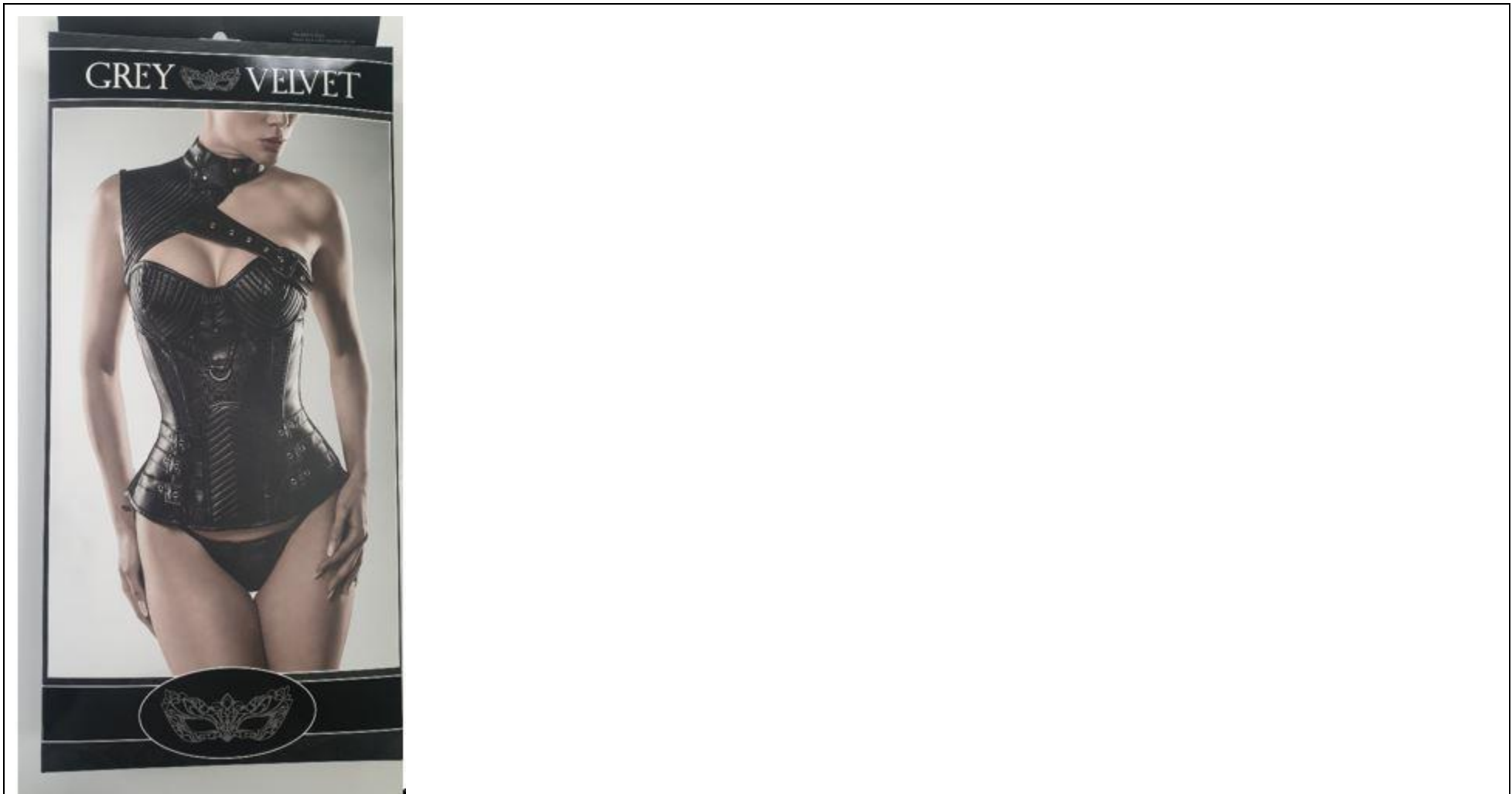
